Student Telephones and Internet Information

Cellular Phones - Students may have a cellular phone on campus as an option for making off-campus calls. The use of cellular phones for purposes other than specifically instructed by faculty or staff is not permitted inside the academic buildings during school hours. Parents should be aware there are no restrictions in terms of content or time filtering available through the school for cellular use. **Students and their parents are responsible for all calls made from individual cellular phones; The Vanguard School cannot be held responsible for calls made, or accepted, on individual cellular phones.**

Internet Service - The Vanguard School is a WiFi campus; internet access is available in all buildings and various "hot spots" on campus. Vanguard offers this free service to its students whose electronic devices are equipped with WiFi. Please see our Computer Network Agreement for more details on number of devices allowed. The wireless network has an **internet content filter** installed, which blocks most undesirable websites. **Restrictions are also placed on the times students may access the internet.**
